Summary:

We are seeking a highly motivated and analytical Occupational Therapist to lead the development and implementation of an Occupational Therapy service within the NMC. You will play a vital role in supporting people with neuromuscular conditions to maintain their independence and quality of life.

The Occupational Therapist will work closely with our physiotherapy and support teams to identify and address the physical, emotional and social barriers to participation in daily activities, and develop personalised solutions and guidance on equipment and adaptations to optimise daily life.

Key Tasks and Responsibilities

Leadership and Development

- To lead the development and implementation of an Occupational Therapy service within the NMC using OT Outcome measures to demonstrate effectiveness.
- To oversee the implementation of all policies associated with that service.
- To collaborate with healthcare and social care professionals to ensure comprehensive care for our community.
- To record, evaluate and monitor the service, ensuring that data is available for potential funding bids.

Assessment & Advice

- To assess people's daily living needs, identifying areas where they may be experiencing difficulties or barriers to participation.
- To conduct home visits to assess living environments and provide personalised advice and recommendations on how to create a safe and accessible living space.
- To work alongside the Physiotherapy team to create individual plans that enable people to participate in daily activities through strategies, equipment and adaptations.
- To provide advice to our community on equipment, home adaptations and technologies. (i.e. walking aids, bathroom adaptations, daily living aids etc.)

Equipment & Technologies

- To develop relationships with equipment suppliers to ensure access to latest products and technologies.
- To plan and deliver equipment demonstration and information days that showcase a range of products and technologies which help people participate in activities and achieve goals.
- To develop the usage of Smart Assistive Technologies within the NMC, showcasing products that could be used in the home environment.
- To work with the NMC Makerspace to design and develop bespoke items.

Education

- To develop an education program that enables better management of fatigue within our community.
- To participate and contribute to the staff in-service training, and the community education programme of the NMC

Safeguarding

- To be part of the Safeguarding Team of the NMC
